- 3. CERTIFIES that said applicant has or will have available, prior to commencement of any work on the project included in this application, the sufficient funds to complete the project should this grant be awarded.
- 4. CERTIFIES that the applicant has or will have sufficient funds to operate and maintain the projects.

- 5. CERTIFIES that the applicant has reviewed, understands, and agrees to the General Provisions contained in the contract shown in the Grant Administration Guide.
- 6. DELEGATES the authority to the Deputy Executive Officer to conduct all negotiations, sign and submit all documents, including, but not limited to applications, agreements, and amendments, which may be necessary for the completion of the grant scope.
- 7. DELEGATES the authority to the Assistant Financial Officer to submit all financial documents, including, but not limited to payment requests, which may be necessary for the completion of the grant scope.
- 8. AGREES to comply with all applicable federal, state and local laws, ordinances, rules, regulations and guidelines.
- 9. ADOPTS the staff report and recommendations dated November 9, 2011.
- 10. AUTHORIZES approval of application for STATEWIDE PARK PROGRAM GRANT FUNDS for the Pacoima Wash El Dorado Park.
- 11. AUTHORIZES any budget amendments as necessary.
- 12. AUTHORIZES the Executive Officer or his designee to do any and all acts necessary to carry out this resolution and any recommendations made by the Governing Board.
