## **NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION**

In accordance with Section 15072 of the California Environmental Quality Act (CEQA) Guidelines, this notice is to inform the general public that the Mountains Recreation and Conservation Authority has completed an Initial Study and Mitigated Negative Declaration (IS/MND) for the Milton Street Park project and intends to adopt the Mitigated Negative Declaration for the project:

**Project Title:** Milton Street Park

**Project Location:** 12500 Milton Street, Los Angeles, CA 90066

**Project Description:** The Mountains Recreation and Conservation Authority is proposing the construction of a linear park that would consist of a pedestrian pathway, overlook areas, a 10-foot by 50-foot shade structure, new access gateway, entry stairs and American with Disabilities Act (ADA) accessible ramp, fencing, native landscaping and irrigation, site furnishings, gabion retaining walls, and interpretive panels on a 1.2-acre parcel along Milton Street, between Mascagni Street and Westlawn Avenue in the City of Los Angeles. In addition, the project would turn the abutting segment of Milton Street into a "Green Street through the construction of vegetated stormwater curb extensions (VSCEs) along both sides of the street. The VSCEs would capture and treat wet and dry weather runoff from the street and park.

**Findings:** The proposed Milton Street Park project would result in potentially significant impacts but compliance with regulatory requirements and implementation of mitigation measures would reduce all potentially significant adverse impacts to less than significant levels.
