# MINUTES of the GOVERNING BOARD of the MOUNTAINS RECREATION AND CONSERVATION AUTHORITY

May 2, 2018

### I. Call to order.

The regular meeting of the Governing Board of the Mountains Recreation and Conservation Authority was called to order by Chairperson George Lange, at 2:00 p.m., on May 2, 2018, at the Conejo Recreation and Park District, 403 West Hillcrest Drive, Thousand Oaks, California.
