



Fernando eventually transitioned from being a naturalist to coordinator of a training program to a Park Ranger. Fernando leads the MRCA Rangers as they protect park lands & provide for public safety. Fernando and his team often serve on the front line of intersection among parks, homelessness and displacement, rescuing people from the LA River and directing people to services.



#### Nathaniel VerGow is the Director of Homeless Services for the Los Angeles Homeless Services Authority (LAHSA) where he directs more than 50 teams of street-based service staff

responsible for outreach across Los Angeles County. He has a Master of Public Health degree and has been working with people experiencing homelessness in various capacities for more than 15 years in Boston, San Francisco, and Los Angeles.



#### Phil Ansell was appointed Director of the County's Homeless Initiative effective August 17, 2015, when he temporarily left his position as Chief Deputy Director

of the Department of Public Social Services (DPSS). During his 19 years with DPSS, Phil played a key role in the design and implementation of numerous programs and services for homeless families and individuals, including a key role in the development of the County's Homeless Prevention Initiative in 2005-06. Effective February 1, 2017, Phil was appointed the permanent director of the County's newly-formed Office of Homelessness.

In his work on homelessness and other major issues impacting low-income families and individuals, Phil has a long history of effective collaboration, both within and outside County government. He coordinated the County's response to federal welfare reform in 1997-98 and chaired the former Interagency Operations Group for many years. In addition, Phil has been a strong advocate for low-income people in Sacramento through the County Welfare Directors Association and in Washington through the American Public Human Services Association.

Phil holds a Bachelor of Arts degree from Stanford University and participated in the Community Scholars Program through the UCLA School of Architecture and Urban Planning. He has been happily married for 33 years and has 2 sons, ages 24 & 28.



Rorie Skei has been involved in Southern California open space preservation and parkland issues for over 40 vears.



As Chief Deputy Director for the Santa Monica Mountains Conservancy, Ms. Skei oversees acquisition, park development, and watershed planning staff; partnerships with local, state, and federal governments; and resource

protection of the 75,000 acres of parkland that have been preserved for the public to date. She also serves ex officio as the Chief Deputy Executive Officer of the Mountains Recreation and Conservation Authority (MRCA), a joint powers agency; and is Deputy Executive Officer for seven other joint powers authorities in which the Conservancy is a member. She is a sworn park ranger with MRCA. Since 1981, she has been the appointed public member and is the current chairperson of the Conejo Open Space Conservation Agency, a joint powers agency between the City of Thousand Oaks and the Conejo Recreation and Park District.

Ms. Skei has long been a California native plant enthusiast and has maintained her home native garden in Thousand Oaks for many years.



Jacqueline Waggoner is vice president and Southern California market leader for Enterprise Community Partners, Inc. She oversees Enterprise's affordable housing, community development, investment and strategic programs from the state's Central Coast to San Diego. Jacqueline started with

Enterprise in 2005. During her tenure, she has employed capital, intellectual resources and capacity building tools to achieve Enterprise's strategic and production goals, leading to more than \$300 million in Enterprise investments locally. She has worked with the city of Los Angeles, banks and nonprofit developer partners to create local funds for affordable housing, advocate for low-income families and support Enterprise's vision of providing communities of opportunity.

Jacqueline serves on the 10-member Los Angeles Homeless Services Authority (LAHSA) Commission, the agency's governing board, appointed by Supervisor Mark Ridley-Thomas in February 2017. She is on the board of directors of the Southern California Association of Nonprofit Housing (SCANPH), a membership organization that supports the production, preservation and management of affordable homes. Jacqueline is on the board of governors of the California Housing Consortium and a board member for the Los Angeles Business Council and Restore Neighborhoods LA, Inc. Jacqueline serves on the steering committees for LA Thrives, a collaborative advancing equitable transit-oriented development, and LA Funders' Collaborative, a network promoting healthy, equitable & sustainable communities.

A Los Angeles native, Jacqueline has a bachelor's degree in sociology and a master's degree in urban planning from UCLA. Her experience in commercial real estate lending spans more than 20 years. Before joining Enterprise, she was vice president for community lending with Wells Fargo Bank in Los Angeles.



Pauline Louie returns to field operations and management at HUD after 4 years coordinating the 14 federal agencies and over 40 stakeholder organizations participating in the Urban Waters Federal Partnership -Los Angeles River. She has spent the prior 14 years leading Sustainability and other Community

Development initiatives for both the Los Angeles and Santa Ana Field Offices. She also returned from leading housing recovery efforts for the 2017 Northern CA Wildfires.

Prior to federal service, Ms. Louie worked in redevelopment consulting and BRAC reuse for Keyser Marston Associates, Inc., and as a Contracts and Grants Administrator for the University of California. Ms. Louie attended UCLA where she earned Bachelor's degrees in Political Science, and in Geography/ Environmental Studies. Also from UCLA, she completed her Master's degree in Urban Planning, with a focus on environmental and transportation policy and planning. She has also completed an executive program in Community Building at the John F. Kennedy School of Government at Harvard University.

Glen Bae works as a Senior Community Planning and Development (CPD) Representative in the LA Field Office of HUD. In this capacity, he provides oversight and assistance to nonprofits and units of local government in carrying out Departmental initiatives and responding to local community development needs. He acts as departmental liaison with entities such as the County of LA's Community Development Commission (LACDC) and Housing Authority (HACOLA), Glendale, Pasadena, among other partners, overseeing a total grant portfolio of \$82 million. Glen has been with the Department for eight years and is a native of Los Angeles. He holds a master of planning degree from the USC Price School of Public Policy.



Dhakshike Wickrema, Assistant Senior Deputy for Homelessness and Mental Health, serves as the lead on policies, programs and advocacy related to homelessness and mental health. Most recently, she supported the Supervisor's successful efforts to pass Measure H, a quarter-cent special sales tax, estimated to raise \$355 million annually to fund strategies to prevent and end homelessness in Los Angeles County.

Prior to joining the Supervisor's office, Ms. Wickrema worked at Shelter Partnership, a non-profit focused on public policy and advocacy related to homelessness and affordable housing. She has also worked for the World Bank's Poverty Alleviation, Health Services and Social Development sectors. Ms. Wickrema earned her Bachelor of Arts degree in English Literature from Illinois Wesleyan University and her Masters degree in City Planning from the Massachusetts Institute of Technology, where she investigated international housing strategies.



Norma Edith García was appointed as Chief Deputy Director of the County of Los Angeles Department of Parks and Recreation in September 2016. She is the first woman to serve in that capacity and executive role in the Department since it Assessment, an effort unprecedented in scope and

scale, that quantified the need for parks and recreation resources in Los Angeles County (including 88 Cities and 156 Unincorporated Areas) and estimated the potential cost of meeting that need. Holding over 140+ community engagement meetings and engaging thousands of community members, this effort served as the groundwork for Measure A: Los Angeles County Safe, Clean Neighborhood Parks and Beaches Measure of 2016 which was passed by the voters with nearly 75% approval rating.

Ms. García is an ardent believer of lifting up children, families and strengthening communities throughout the County, and works tirelessly to achieve this through her active participation in many civic and professional organizations. She currently serves on the Governing Board of Trustees for Rio Hondo College, the Board of New Economics for Women and the El Monte Promise Foundation. Ms. García's work has been highlighted by the White House Initiative on Educational Excellence for Hispanics in 2015 and invited to the White House by President Barack Obama. In 2016, Ms. García was invited to participate and share the stage with former President Clinton at the Clinton Global Initiative America. Ms. García received the 2017 First District Women of the Year by the Los Angeles County Commission of Women and Supervisor Hilda Solis and the 2018 Woman of the Year for the 22nd California Senate District. Ms. García is a graduate from the Hispanas Organized for Political Equality (HOPE) Leadership Institute and was awarded a Conflict Resolution Fellowship through the U.S. State Department in Indonesia.

Ms. García graduated from UCLA, earning a B.A. in Political Science and M.A. in Urban Planning. Ms. García and her adventurous family of boys and huskies enjoy California road trips and everything about parks and the great outdoors.

**Dominic H. Choi** was born in Los Angeles, California, and currently resides in Orange County. He graduated from Canyon High School in 1988, and continued his education at the University of Southern California where he obtained a Bachelor of Science in Accounting. Commander Choi began his career with the Los Angeles Police Department on November 27, 1995. **Albert Torres** currently serves the Los Angeles City Department of Recreation and Parks at the lead in addressing illegal encampments and bulky items at 444 city parks, including 12 regional parks, 182 recreation centers, and 16,000 acres of open space. Over his 35 years as a park ranger, he has been involved in assisting

homeless people his entire career. Having made thousands of contacts in the field with homeless people, Ranger Torres is recognized as a department expert and speaks to community groups, department staff, and professional groups. Each discussion starts and ends with the work compassion. Compassion toward each person and their circumstance, with the hope of a better outcome. Compassion toward community and the impact of the park conditions.



**Craig Sap** began his career with California State Parks in April 1983 as a Seasonal Lifeguard at Ventura and Carpinteria Beaches working summers while attending college at the University of California at Santa Barbara.

In 1997, Craig became a full time Lifeguard at Huntington and Bolsa Chica State Beaches and was eventually

promoted to the Public Safety Superintendent for the Angeles District in 2007.

His first Superintendent assignment was also in 2007 when he became the Acting Sector Superintendent for Los Angeles Sector.

Craig became the Acting District Superintendent of the Angeles District in 2010 and in 2012 was appointed to the position.

Mr. Sap brings a wide variety of park knowledge and has had a great deal of experience with State Parks in urban settings.

**Miguel Luna** is an immigrant from Colombia who works on water, people, and smiles. He is a principal at DakeLuna Consultants and founder of Urban Semillas. He is sought after and respected locally, regionally, and statewide for his expertise in working with diverse communities and for his ability to utilize community

reconnaissance in order to develop and implement effective outreach tools and to deploy community engagement mechanisms for coalition and consensus building. Miguel serves on a myriad of boards that focus on water education, pedestrian advocacy and mobility, youth education, economic development, open space conservation, and community access to the outdoors.



**Dan Knapp** assumed the role of Executive Director/ CEO of the Conservation Corps of Long Beach (CCLB) on February 1, 2016. Prior to joining CCLB Dan served as Deputy Director of the LA Conservation Corps. Dan worked for the LA Conservation Corps for 19 years, the past 10 years in

the role of Deputy Director. He started working for the LA Conservation Corps as an environmental science teacher during the summer of 1996 thinking that he'd work for the Corps for a year or two, at the most. His initial goal was to impart his love and passion for the natural environment to the young people of the Corps. Dan quickly realized that for the young people of the Corps to appreciate and value the importance of conservation they first and foremost must appreciate and value themselves. It was that revelation that hooked him and made me a firm believer in the mission of the Corps (Dan likes to say that he not only drank the Kool-aid, he guzzled it).

At the LA Corps Dan was responsible for over \$25 million in project funds. Dan has been involved in a broad spectrum of projects including: the development of award winning environmental education programs, large scale restoration projects, the development of a residential program in the San Bernardino Mountains, innovative urban forestry programs, as well as a myriad of resource conservation and environmental justice projects and programs. In California, he has served as vice-president of the CA Association of Local Conservation Corps (CALCC) that represent 13 certified local conservation corps programs.
