BID TERMS:

Bids in duplicate, subject to the instructions, terms and conditions of this Invitation for Bids, and such other contract provisions, specifications, drawings or other data as are attached will be received at the Mountains Recreation and Conservation Authority (MRCA), 570 West Avenue 26 Suite 100, Los Angeles, CA 90065 **by 2:00 PM, local time on Tuesday, January 29, 2019**, and at that time publicly opened and read aloud. Please mark your bid envelope "**SEALED BID: MUNICIPAL LEASE AUTOMOBILE RFB**".

Please note that all bids must be received at the designated location by the deadline indicated. Bids received after the deadline will not be considered for the award of the contract, and shall be considered void and unacceptable. Bidders, their representatives and interested persons may be present. Contract will not be awarded at the time of the bid opening. MRCA shall analyze all bids to determine lowest responsible bidder based on the needs of MRCA, and may award multiple contracts.

MRCA will tentatively select a successful bidder by February 12, 2019. Bidder will be given the opportunity to propose a phase-in schedule for initial vehicle delivery. Replacement schedule for vehicle ordered under the contract will be established based on the conditions of the selected.

Mountains Recreation and Conservation Authority (MRCA) plans to acquire one (1) new vehicle as described in this Request for Bid. MRCA prefers to select a single company to satisfy its requirements. This request for bids does not order any specific items, nor does it create an obligation of funds. MRCA obligates funds through issuance of separate documents. Mountains Recreation and Conservation Authority reserves the right to reject any or all bids, to waive technicalities, to re-advertise, to proceed otherwise when in the best interest of the agency.

Bids should be submitted under company letterhead stationery with the information required in this RFB. As a minimum, bids must include two (2) copies of all bid documents sealed in one envelope with the following completed pages:

- 1) RFB Cover Pages (Pages 1, 2, 3, and 4 of the bid package)
- 2) Completed Pricing Sheet (Page 8 & 9 of the bid package)
- 3) Vendor Responsiveness Sheet (Page 9 of the bid package)
- 4) Contract Administrative Data: Designate points of contact for this proposed contract. Indicate primary point of contact for negotiations, if multiple contacts identified (Page 8 and 9 of the bid package).
- 5) Include any Contract Agreements that MRCA would be required to sign. The lease agreement will be reviewed by MRCA before any award will be announced.
- 6) Provide manufacturer's statement of warranty for the automobile type with bid.
- 7) Attach copy of Lease Agreement.

DELIVERIES OR PERFORMANCE:

NOTE: This lease is for a new model available from existing inventory or ASAP.

The bidder proposes to deliver vehicle within the following period after receipt of an MRCA Purchase Order for a given vehicle(s): _____ (bidder to fill in blank in Vendor Responsiveness Page). In the event delivery cannot be completed within this period, the Vendor shall notify MRCA when it becomes aware it cannot meet the schedule and shall indicate the reason for delay and a projected delivery date. MRCA reserves the right to cancel the order at that time without cost to MRCA. In any event, MRCA's obligation to pay does not commence until MRCA accepts delivery of a vehicle from the Vendor.

SERVICES AND PRICES/COSTS:

MRCA requires new vehicles satisfying the specifications described in this section. Bidders are expected to submit proposals that comply with all portions of this section as well as "minimum vehicle specifications" and all specifications related to vehicle types. If a bidder is unable to satisfy every element but chooses to submit a proposal anyway, it must clearly identify the element(s) it is unable to satisfy and the reason it cannot meet the requirement. MRCA will review any exceptions taken but, at its sole discretion, may determine the proposal not responsive to MRCA's requirements and remove it from further consideration.

For evaluation purposes MRCA is requiring all vendors to use the following lease parameters:

- List all applicable fees and charges.
- Vendor will be responsible for licensing and registration of the vehicle to MRCA with exempt license plates and applicable taxes.
- Five (5) year municipal lease with no mileage restrictions.
- Vehicles must be depreciated at to a \$1 Buyout

DESCRIPTION/WORK STATEMENT:

Project Organization and Management

The Vendor shall establish and maintain an appropriate organizational structure to enable local management of the lease portion of this contract. Documentation supporting the Vendor's ability to service the contract (including but not limited to office locations) should be included with the bid submission. All ordering will originate directly from MRCA.

Title, License, and Registration

The Vendor shall be responsible for providing a vehicle that is properly titled and is tagged in California where it will be operated. Fees associated with titling and tagging of exempt plates shall be the responsibility of the Vendor and shall be considered included in prices paid under this contract.

Vehicle Inspection

The vehicle leased under this contract shall be inspected by MRCA prior to taking possession, at which point vehicle inspection documentation will be provided indicating the general condition of the vehicle.

Condition of Leased Vehicle

The vehicle furnished under this contract shall be of good quality and in safe operating condition. MRCA shall accept or reject the vehicle promptly after receipt. If MRCA determines that any vehicle is defective or unsafe at delivery, MRCA shall promptly inform the Vendor in writing.

Funding Information

This contract does not, in itself, order any specific vehicles, nor does it create an obligation of funds. MRCA obligates funds through issuance of separate documents labeled "purchase orders". Prior to placement of orders, MRCA expects to issue purchase order(s) containing sufficient funding to cover the projected need through the end of the then-current ordering period.

Invoice Instructions

Detailed invoicing instructions will be negotiated between MRCA and the tentatively selected Vendor. Any credits due MRCA shall be separately identified on the invoice and shall be applied against outstanding charges due to the Vendor.

Order of Precedence

The terms and conditions of this contract take precedence over any Lease documents that may be signed by MRCA.

Evaluation of Bids

MRCA intends to evaluate bids based on initial written presentations and to make a tentative selection of a successful bidder with whom MRCA will then engage in negotiations to finalize a contract.

REPRESENTATIONS, CERTIFICATIONS, AND ACKNOWLEDGMENTS:

Successful bidder shall defend, indemnify and save harmless Mountains Recreation and Conservation Authority and all its officers, agents and employees from all suits, actions, and other claims of any character, name and description brought for or on account of any injuries or damages receiver sustained by any person, persons, or property on account of any negligent act or fault of the successful bidder, or any agent, employee, subcontractor or supplier, in the execution of or performance under, any contract which may result from award. Successful

bidder shall pay any judgment with costs, which may be obtained, against Mountains Recreation and Conservation Authority growing out of such injury or damages.


