Dear Mr. Sandoval:

We are pleased to submit the following proposal for Professional Services in connection with the project

referenced above.

This Agreement is by and between SWA Group ("SWA"), a California corporation, and MOUNTAINS

RECREATION & CONSERVATION AUTHORITY ("Client"), Los Angeles, California (location).

SWA shall provide professional services on the project referenced above, and described in greater detail

below, under section I. Project Understanding and Assumptions.

I. PROJECT UNDERSTANDING AND ASSUMPTIONS

The site for the project is a largely undeveloped area of land in the Ramona Gardens Housing Development, approximately 176,785 sq. ft. in area, north of the Interstate 10 freeway and south of the Ramona Housing development in Boyle Heights. The site is used for a Swap Meet on the weekends and includes green and recreational areas.

- Feldman Consulting, on behalf of MOUNTAINS RECREATION AND CONSERVATION AUTHORITY (the Client), will manage the Technical Team, and will provide design input, project direction and coordination with MOUNTAINS RECREATION AND CONSERVATION AUTHORITY. The Technical Team includes VS2 Consulting and SWA, and other sub-consultants.
- 2. Unknown items below are to be clarified as the project progresses based on the forthcoming, established and agreed-upon schedule:
- · Additional Swap Meet data / notes per Feldman Consulting.
- Alternative Swap Meet location / relocation by Client and others (placeholder as part of construction cost estimation). SWA to establish general parameters that would support the Swap Meet at an alternative site.
- Integration of requirements (if any) for job creation opportunities.
- Integration of requirements for training (adults, teenagers).
- LAPD Safety and Security requirements; data / notes per Feldman Consulting.

II. SCOPE OF SERVICES

The scope of services is based on Concept Design, including the Concept Report (*Concept Plan & Community Engagement Report*) and shall include:

- A. SWA shall be involved in Project Launch & Team Coordination; co-developing schedule with Feldman Consulting and the Technical Team; and provide Design Consultation for the following items to be included in Deliverables:
- Illustrative Plan updated, at 11x17.
- Hardscape / Paving Plan to include Plaza / Swap Meet, paths, entries, Plaza, Sculpture Garden/Play Area and Recreation areas
- Planting Plan including hydrozones (in coordination with Land IQ)
- Site Furnishings (and general signage locations)
- Concept Lighting Plan. Note: SWA is not a Lighting Consultant but can suggest conceptual location of light fixtures on site.
- General Best Practice recommendations on security and landscape (i.e. planting heights)
 with coordination with Land IQ. Note: SWA is not a Security Consultant.
- Five types of sections to include a combination of Cross Sections and Sectional
 Perspectives. Intent of Sections is to illustrate use of Swap Meet; show mechanics of how
 walking trails, community uses, air quality and water improvements work in the Plaza and
 Trail.
- Update the following diagrams included in Concept Report (Concept Plan & Community Engagement Report):
 - o Illustrative Plan
 - Urban Runoff and Stormwater Re-Use (Water)
 - Native Habitat (Planting)
 - o Public Use, Art, and Recreation (Zones)

III. PROCEDURE

A. Schematic Design

Based on Concept Design, SWA shall prepare schematic design drawings defining the general concept of landscape architectural design and for cost estimating purposes, per Section II SCOPE OF SERVICES, above.

IV. DEVELOPMENT BUDGETS

Based upon the current level of information on the project, and our understanding of the present concept, SWA will refine project per items under the above scope of services. The fee quoted in this proposal is based upon our understanding of the approximate construction budget developed in Concept Design.

V. DESIGN APPROVAL

Esther Feldman from Feldman Consulting has been designated as the person responsible for design direction to SWA for this project and Mario Sandoval from MOUNTAINS RECREATION & CONSERVATION AUTHORITY has the authority for design approval. In the event that the design, as approved by MOUNTAINS RECREATION & CONSERVATION AUTHORITY is rejected by others, and redesign is required, such re-design services shall be compensated as Additional Services.

VI. MEETINGS AND SITE VISITS

This proposal includes Professional Service time for up to five (no. 5) physical (face-to-face) meetings for coordination with the Technical Team, Client, agencies, consultants or Owner and Project Team.

Additional meetings shall be billed as Additional Services. Travel expenses shall be billed as Reimbursable Expenses.

VII. EXCLUSIONS TO SCOPE OF SERVICES

Client shall provide the following information or services as required for performance of the work. SWA assumes no responsibility for the accuracy of such information or services and shall not be liable for error or omissions therein. Should SWA be required to provide services in obtaining or coordinating compilation of this information, such services shall be charged as Additional Services.

- A. Topography and boundary surveys.
- B. Legal descriptions of property.
- C. Soils testing and/or engineering.
- D. Existing site engineering and utility base information.
- E. Overhead aerial photographs at controlled scale.
- F. Engineering other than that provided within the Scope of Services.
