Resolved, That the Governing Board of the Mountains Recreation and Conservation Authority (MRCA) hereby:

- 1. FINDS that Assessor Parcel Number 1033-171-41– 0000 (formerly APNs 1033-171-12 and 13) possesses high ecological and habitat value and provides significant public benefit; and
- 2. FINDS that the subject 80 acres are high priority acquisitions for the State Park system; and
- 3. FINDS that the proposed actions are categorically exempt from the provisions of the California Environmental Quality Act (CEQA); and
- FINDS that the use of referenced grant funds for acquisition of the identified property is an appropriate expenditure; and
- 5. FINDS that appropriate stewardship funding will be provided; and
- 6. ADOPTS the staff report and recommendation dated February 3, 2021; and
- 7. AUTHORIZES the execution of California Wildlife Conservation Board Grant Agreement for Acquisition of Fee Interest number WC-____ and the acceptance of grant funds from the listed agencies for the purpose of acquisition of the identified property; and
- 8. AUTHORIZES the fee simple acquisition of Assessor Parcel Number 1033-171-41–0000 (approximately 80 acres) in the City of Chino Hills; and
- 9. AUTHORIZES acceptance of stewardship funding; and

10.	AUTHORIZES any budget amendments as necessary, and
11.	AUTHORIZES transfer of said property to California State Parks; and
