Permit Requirements, Conditions, and Rules

- Permittee agrees to follow all park rules.
- Permittee declares that images for this photo session are for personal use and will not be sold or used for profit. No commercial use of photos for marketing & advertising, publications or similar projects for a market audience.
- Permittee agrees that photography will take place during the normal hours park hours. Professional props or sets, actors or professional models, or specialized or large motorized equipment will not be used.
- There must be no interference with other park visitors' use and enjoyment of the park.
- Permittee hereby agrees that it will not use footage, stills, and any other images from the Property or any other MRCA or SMMC property in any production that portrays the MRCA, SMMC, Conejo, Rancho Simi or any officer, employee, agent or affiliate thereof in a false or defamatory light.
- Permittee will exercise the utmost care to see that no park facility or feature is disturbed or rearranged. Photographing or filming of resident wildlife will be permitted only when such wildlife will not be molested, harmed, or disturbed thereby. Wildlife captured elsewhere and will not be allowed in any filming whether trained or not. Domestic animals may be used if humane treatment is maintained at all times.
- Permittee will stay within allotted time described in invoice or pay additional fees. Permittee agrees not to release anything into the air or on the grounds. Permittee will not light up any fire and will not serve alcoholic beverages. Permittee understands that entry into the buildings is not allowed.
- Fees are non-refundable. Permittee may postpone session once (1) to a later date in the same calendar year. If the new date is the following year, Permittee must abide by new rates. Fee schedule is subject to change.
