REQUEST FOR BIDS COMPACT TRACK LOADERS, TOW TRAILERS & ATTACHMENTS

The Mountains Recreation and Conservation Authority (MRCA), a local public agency exercising joint powers pursuant to Section 6500 *et seq*. of the Government Code, seeks a Vendor to provide, program, set up, deliver, and provide service for specified Compact Track Loaders, Tow Trailers and Attachments.

Delivery and Performance:

The requested items must be delivered to 570 West Avenue 26, Los Angeles, CA 90065 by July 15, 2022. In the event delivery cannot be completed within this period, the Vendor shall notify MRCA when it becomes aware it cannot meet the schedule and shall indicate the reason for the delay and projected delivery date. MRCA reserves the right to cancel the order at that time without cost to MRCA. In any event, MRCA's obligation to pay does not commence until MRCA accepts delivery of goods.

Bid Terms:

Bids will be received at the Mountains Recreation and Conservation Authority (MRCA), 570 West Avenue 26, Suite 100, Los Angeles, CA 90065 until **11:00 AM, local time on April 1st, 2022**. Bids received after the deadline will not be considered for the award of the contract and shall be considered void and unacceptable.

Bids must include the following:

- 1. Completed, signed Bid Submission Form and Schedule(s) of Bid Items (up to 3 schedules).
- 2. Include any Agreements that MRCA would be required to sign. The agreements will be reviewed by MRCA before any award will be announced.
- 3. Cut sheets for proposed equipment.

Bids must be submitted on the prescribed forms. All blank spaces for bid prices must be filled in, in ink, in both figures and words where indicated. Interlineations, alterations and erasures must be initialed by the signer of the bid. The MRCA reserves the right to reject any bid improperly prepared or which does not contain all information required as indicated.

Selection:

Selection will be based on cost and ability to perform required service, but proposed deviations from the requirements will be noted and taken into consideration. Bids shall be valid for a period of at least 90 days after the bid submission date.

MRCA may award multiple contracts. MRCA will make three (3) separate determinations of lowest responsive and responsible bidder for:

- **BID A:** the Bobcats with attachment (items 1, 2, 3—see page 6);
- **BID B:** the Towmaster trailers (item 4—see page 7); and
- **BID C:** the trailer winch (item 5—see page 8).

All elements requested for each respective equipment type must be included for a bid to be deemed responsive. **Vendors who are bidding on all three groups of equipment must submit three separate forms.** Do not combine bids on a single form (except for Bid A which contains 3 items).

Substitutions:

Vendors submitting bids for alternate or equal products shall submit specifications and cut sheets with their response.

This request for bids does not, in itself, order any specific items, nor does it create an obligation of funds. MRCA obligates funds through issuance of separate documents. Mountains Recreation and Conservation Authority reserves the right to reject any or all bids, to waive technicalities, to re-advertise, to proceed otherwise when in the best interest of the agency.

BID ITEM SPECIFICATIONS:

Provide, setup and deliver the following items:

BID A – see page 6

1. (1) Bobcat T- 450 compact track loader

Must come with a standard Cab C-10 package, with joystick controls; P-10 performance package - Manuel Bob Tach standard flow, single speed performance, horsepower-55, operating weight - 6424 pounds, auxiliary flow- 16.7, and powered with a Tier-4 rated engine, with a 62' combination bucket attachment.

2. (1) Bobcat T- 450 compact track loader

Must come with an enclosed Cab C-20 package, with joystick controls; with a P-10 performance package - Manuel Bob Tach standard flow, Single speed performance, horsepower-55, operating weight 6424lbs, auxiliary flow-16.7 and powered with a Tier 4 rated engine, with a 62' heavy duty bucket loader attachment.

3. (1) Trencher LT- 213 attachment

The operating weight should be no more than 725lbs, with a flow range from 11 to 18 GPM, dig depth – 36', and maximum operating pressure of 3300 PSI.

4. (2) Tow - Master Trailer T-14D

Trailers Must have an approximate payload of 14,000/6350, GVWR of 18,200/8255, GAWR of 14,400/6531; must come with: adjustable hitch height, RV electrical plug, grommet mounted LED lights, Mud flaps, and adjustable ramp with spacing.

5. (1) Trailer Winch

Must have a rated line pull of 5800lbs, motor: permanent magnet 1.87HP 12 vDC, controller: wired handheld 20 feet lead, geartrain: three stage planetary, gear ratio: 218:1, wedge mounting bolt pattern: 4.5x 4", plate mounting bolt pattern: 12x 5.8", and weight: 57lbs.

- All items requested shall be ready for use, fully assembled, and in good operable condition. Full instructions and equipment specifications must be provided.
- All items shall be guaranteed to be free from defects in materials or workmanship during normal use and installation.
- Upon written notification to the vendor of a product's failure to conform to any of the
 aforementioned warranties during the applicable warranty period, the Vendor shall
 correct such failure/nonconformity by repairing the defective part(s) within 60
 calendar days of receipt of the notification. The vendor will warranty the replacement
 part(s) for the remainder of the original warranty period.
