Dear MRCA Board Members:

I feel that there is a problem with the SCPA Board.

I am a resident of Sullivan Canyon, the president of the SCPOA (Sullivan Canyon Property Owners' Association) and a member on the SCDRB (San Vicente Scenic Corridor Design Review Board).

My concerns are:

- 1) It is my opinion that the SCPA has increasingly changed their Rules to facilitate the growth of commercialization at the site.
- 2) It is my opinion that the president of the SCPA Tanya Stivers has aligned herself with what I would consider to be one of the most prolific commercial trainers at the site, Traci Brooks with Balmoral Farms. Traci never lets anyone keep their personal horse at her facility (let alone one that is not Hunter/Jumper as Tanya rides dressage) yet she lets Tanya keep her horse at 1781 Old Ranch Road (ORR) which I would consider to be a conflict of interest.
- 3) SCPA board member Larry Watts has continued to state that there is nothing the SCPOA can so to stop the increasing commercialization aspect of the SCPA, that it is just the new norm. He has stated that he feels that if we make it less commercial that the trainers will leave and the SCPA won't have enough money to operate.
- 4) It is my opinion that, by allowing the SPCA facility to be, in effect, run by the trainers, the trainers have taken up most of the corrals (even keeping them empty just to tie them up) making it difficult for independent riders to come in. They have caused to be created "feeder facilities" such as Ashley Kaplan's facility at 13160 Riviera Ranch Road (RRR), where future members ride until they're good enough to ride on site (Ashley's place is considered the "lower arena" and the SCPA is the "upper arena". The end result of this is making it extremely exclusive to people who don't have the means to retain the services of a private trainer and the horses they own in order to be able to ride at the SCPA facility.

That said, it concerns me that some of the people running for the lifetime position of the MRCA/SCPA liaison are either pro commercialization and/or tied to the commercial trainers, specifically, in my opinion, Ashley Kaplan. In my opinion, I would consider

Ashley's facility at 13160 RRR a commercial facility. FYI, Ashley doesn't live there, just the grooms. While Traci has her main facility at 1781 ORR (right in the heart of Sullivan Canyon) her clients are also at Ashley's facility at 13160 RRR (see Balmoral sign photos at Ashley's facility below as I zoomed in).



These equine facilities are all located within our residential areas. You can check them out on Google Earth.

I remember when the kids used to take care of their horses and walking them down the canyon. Now they aren't allowed inside of the facilities. Instead, the grooms with their ATVs and walkie-talkies shuttle the horses up and down the street and have them ready for the kids to jump on and take their lesson then leave. The entire aspect of caring for your horse is gone, it has just become an exclusive activity for a kid to do. This is what Larry keeps referring to as the new norm. Well, I don't buy it, that it has to be commercial so that the trainers won't leave, that we need to have the SCPA facility cater to the commercial trainers.

Despite what some SCPA board members have been preaching to the equine community, everyone in our residential community loves the equine aspect of our community and wants to preserve the number of horses currently in the canyon. That is why we chose to live here. This is why we all supported the SCPA when it was founded. As president of the SCPOA, I have never received a complaint about the horses (and yes I get a lot of complaints).

I feel that the MRCA needs to step back and really dig into what is going on with the SCPA Board and how their selection of the MRCA/SCPA liaison will have an impact on this. A fair and balanced board would be the ultimate goal: one that respects the surrounding community; one that is willing to return to the original Rules (before the trainers started having the SCPA board change them in their favor).

I feel that the commercialization of the SCPA facility is all easily solvable if the SCPA Board would implement the following rule changes:

- 1) Add no compete clause within a 500-yard radius. This would eliminate the trainers coming in and buying up property and creating these "feeder facilities".
- 2) Limit number of students per trainer.

- 3) Limit number exercise riders per trainer, as this allows them to have more horses and students.
- 4) Limit assistant trainer days. This will limit trainers who are on the show circuit and not here to train during shows.
- 5) SCPA can limit the number of corrals per trainer in order to free up space for independents to come and ride.

Furthermore, Anne Dobkin attended our SCPOA Board Meetings, not as a voting member of our board, but as the MRCA liaison. I believe that the MRCA made a commitment that our community would always be represented. That said, I feel that any nominee should live in our community and have the final selected person be under the condition that they have to regularly attend our board meetings. This is important to us as this is our only connection to the SCPA.

I know a lot of this isn't within your jurisdiction, but hopefully the new MRCA/SCPA liaison would be able to influence this as well as help implement the rule changes mentioned above. I hope you give the selection process for the MRCA/SCPA liaison position the attention it deserves. Who would have thought that such a minor position would have become so political but yet, here we are.
