# ADDENDUM #01 issued March 16<sup>th</sup>, 2023. 2023 Fuel Modifications/ Brush Removal

To: ALL PROSPECTIVE BIDDERS

# A. QUESTIONS FROM BIDDERS & RESPONSES

#### FIRST QUESTION

Is there an expected start date for clearing parcels as well as a hard completion date?

The prospective bidder must agree to wait and be issued a written "Notice to Proceed" issued by MRCA, which can be expected by the first or second week of May, if all paperwork is in place, including but not limited to:

- a. Any contract over \$25,000.00 has board approval.
- b. Contractual agreements are fully executed.
- c. All insurance requirements have been met.
- d. All contracts over \$15,000.00 have been registered with the Department of Industrial Relations.

The hard completion date will depend on how many bid items are awarded to contractor, and the acreage per property. Usually, a deadline will be by the first week of July. Again, depending on how many properties were awarded to one contractor will dictate a deadline for a hard completion date. Thus, if awarded, the start date and hard completion date will be defined in the fully executed standard agreement(s) between MRCA and awarded Contractor.

### SECOND QUESTION

Would a C-27 license be suitable to bid this project in lieu of a D61/D49?

# Yes, a C-27 will be suitable, as long as you can provide a list of references for fuel modification projects pertaining to the Los Angeles area.

## THIRD QUESTION

Can you please confirm the date for Sealed bids and where they will be publicly read?

All sealed bids will be due Tuesday March 21<sup>st</sup>, by 2pm at King Gillette Ranch, located at 26800 Mulholland highway, Calabasas CA 91302. Sealed bids can be mailed or dropped off. (If sending; Please send to MRCA representative – "Attention Leigh Croley"). Sealed bids drop off: will be publicly read at the Anthony C. Beilenson visitor center at KGR. (Please look for a Red "Bid opening" banner).

B. Clarification or any other notice of a change in the bidding documents will be issued only by the OWNER, MRCA, and only in the form of a written Addendum, and uploaded to the MRCA website.
