Work Location: Santa Maria and Summit to Summit 1 (Los Angeles County)

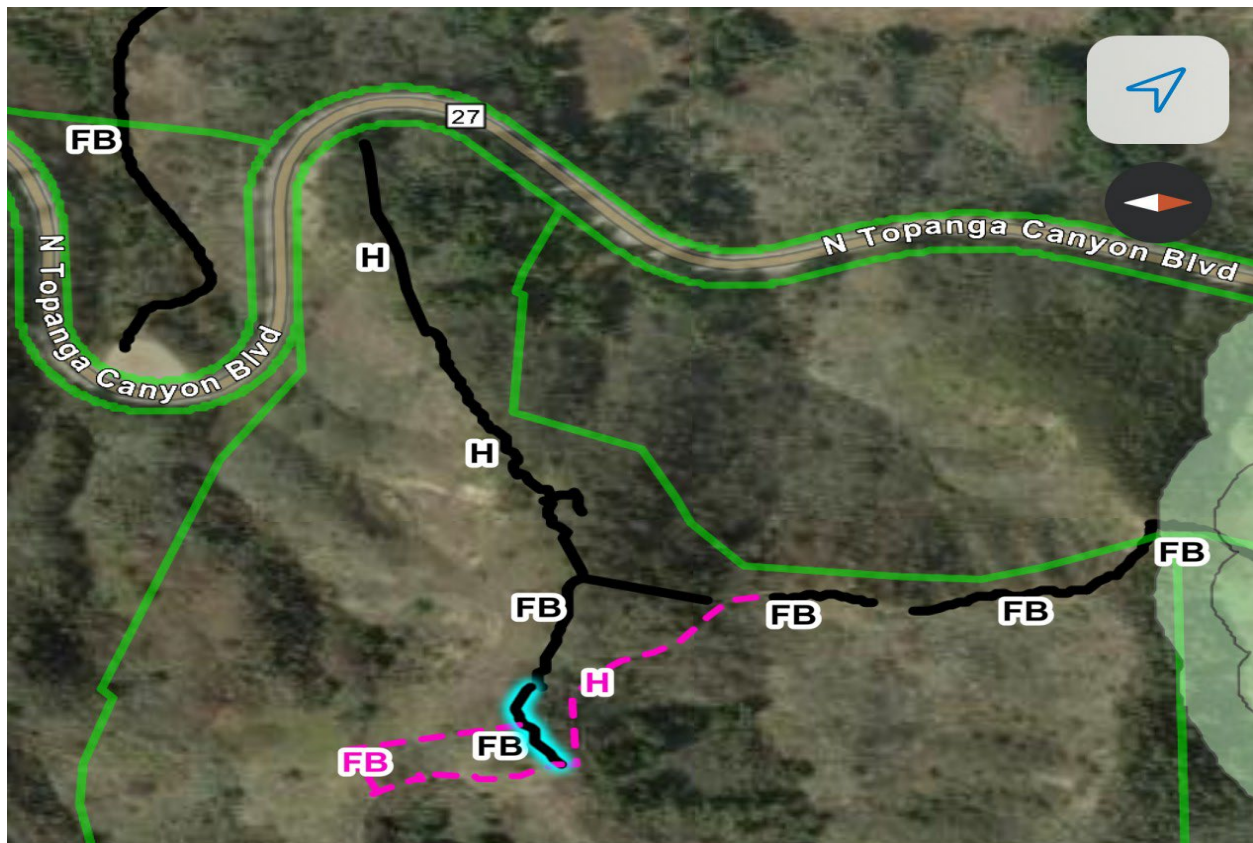

Overview:

Crews working on the fuel break at Summit to Summit 1 continued improving the burn piles by increasing the spacing between them and reducing their overall height.

The fire crews working on the Santa Maria side began constructing a fuel break with burn piles starting from Viewridge trail and heading towards highway 27. The fuel break spanned the total width of the ridgetop with piles located along the middle of the ridgetop. Additionally, the green climber worked alongside the crews masticating around the piles they were building. A total of 215.8 feet of the fuel break was completed.

The masticator cleared 20 feet of brush along both sides of Summit-to-Summit Motorway beginning at the entrance from Old Topanga. The masticator cut a total length of 1,440.4 ft along the fire road.

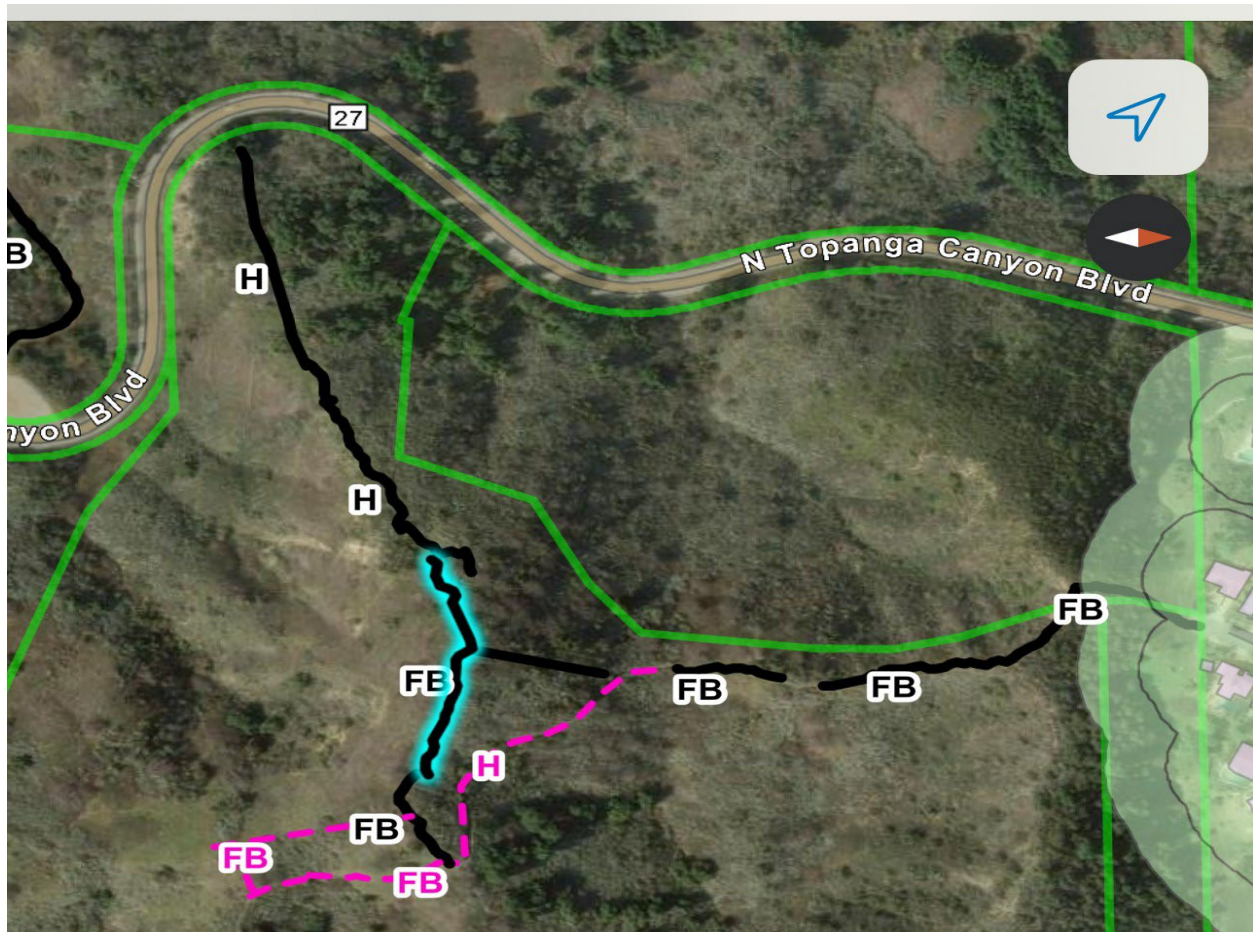

Overview:

Crews working on the fuel break at Summit to Summit 1 continued improving the burn piles by increasing the spacing between them and reducing their overall height.

The green climber continued to masticate the vegetation around the piles and clearing the total width of the ridgetop. An additional 479.7feet of the fuel break was completed.

The masticator cleared 20 feet of brush along both sides of Summit-to-Summit Motorway begging at the entrance from Old Topanga. The masticator cut a total length of 2,288 ft along the fire road.

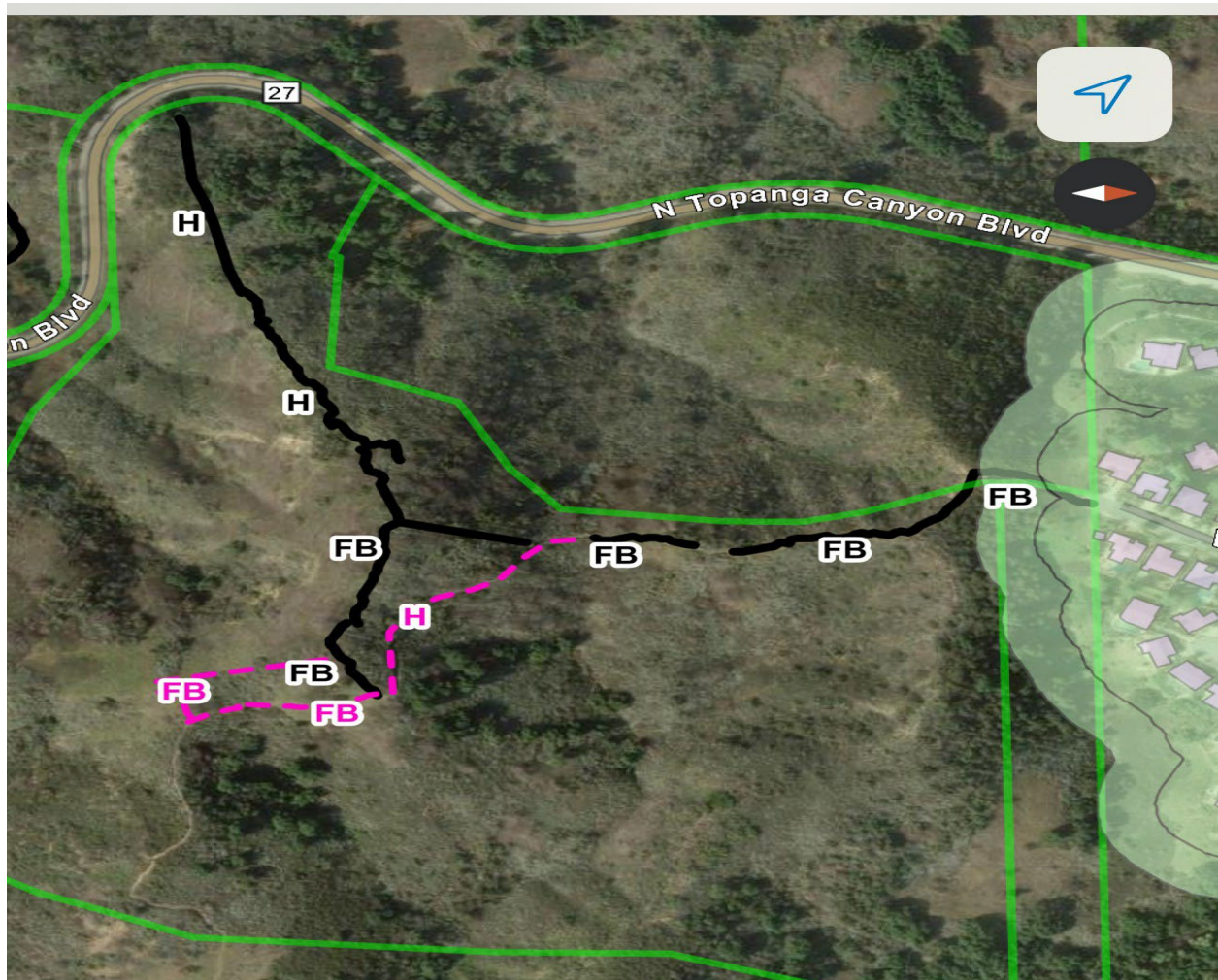
Work Location: Santa Maria and Summit to Summit 1 (Los Angeles County)

Overview:

The fire crews continue to work on the fuel break alongside the green climber. The crews continued to build burn piles while the green climber improved clearance along the ridgetop. An additional 1,037.4 ft was completed tying the fuel break into highway 27.

The masticator cleared 20 feet of brush along both sides of Summit-to-Summit Motorway begging at the entrance from Old Topanga. The masticator cut a total length of 3,023 ft along the fire road.

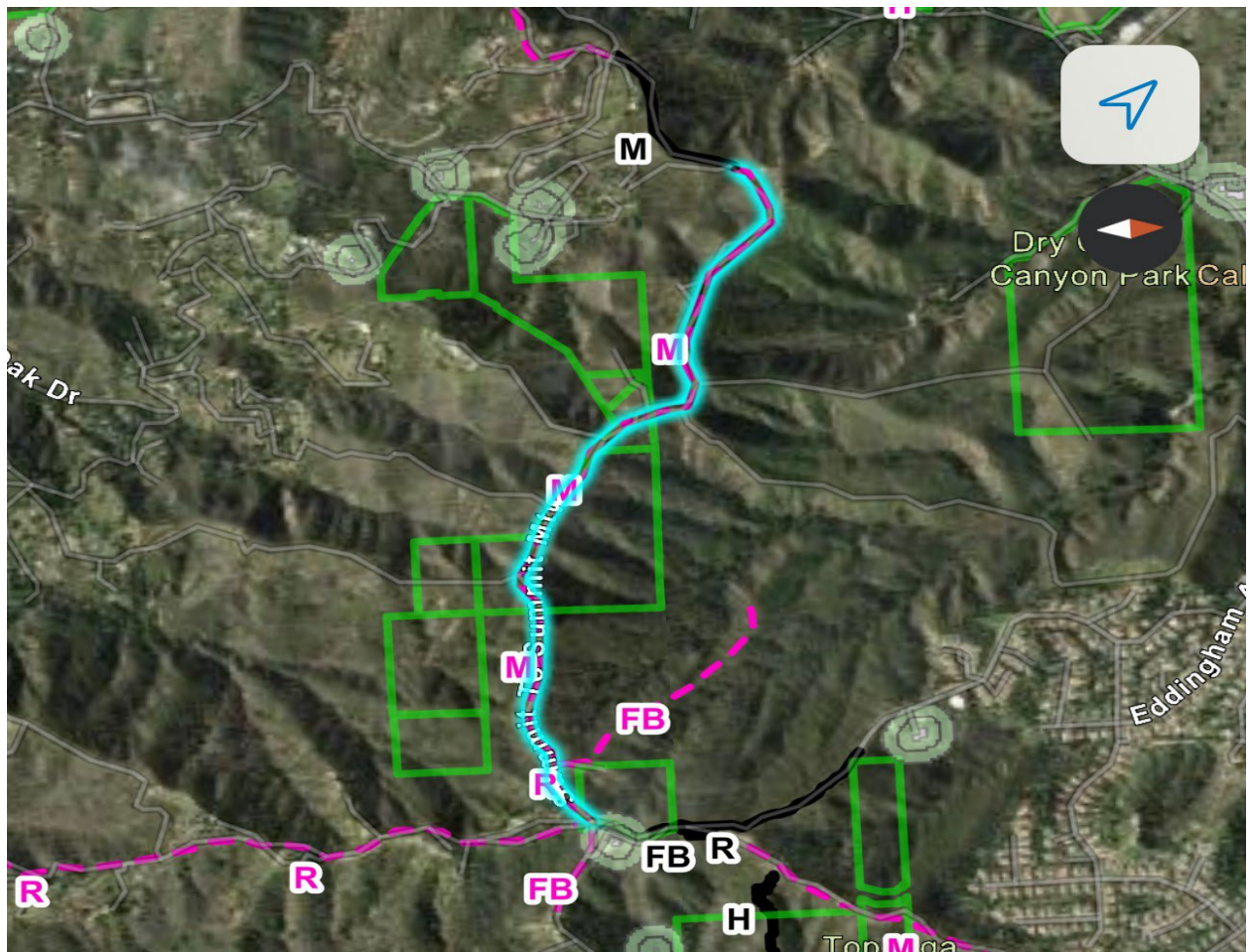

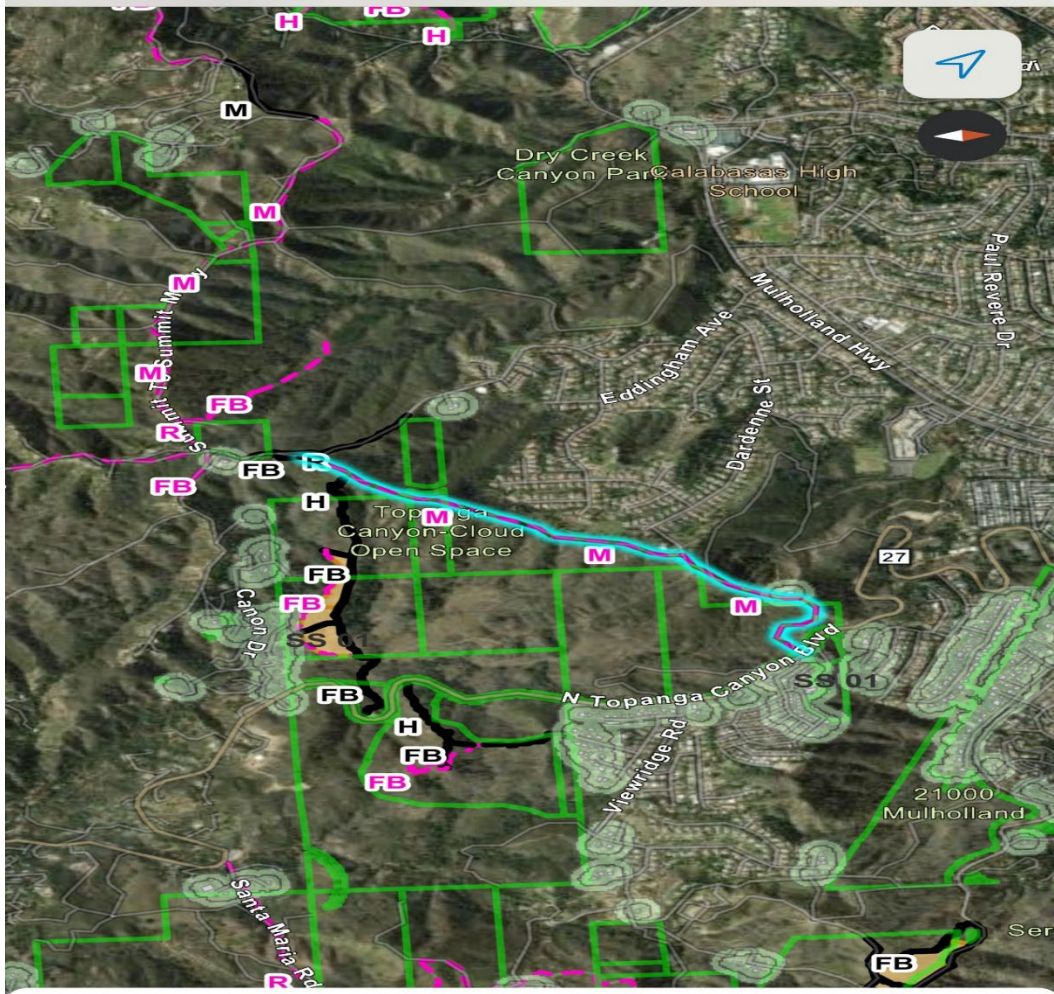
